

Twin Rocks Undersea Memorial

Instruction and Forms

To order a Twin Rocks Undersea Memorial Obelisk, three forms must be completed and received:

A. Authorization and Forms

- Authorization for Final Disposition

Have the authorized representative complete the "Authorized for Final Disposition" form. This form needs to be signed by the legal custodian of the remains and witnessed. This form authorizes us to create the Undersea Memorial Obelisk.

- Twin Rocks Undersea Memorial Policy and Procedure Statement

Have the authorized representative read and sign the Twin Rocks Undersea Memorial Policy and Procedures Statement.

- Twin Rocks Undersea Memorial Order Form

Have the authorized representative complete the Twin Rocks Undersea Memorial Order form. This identifies the contact person, the information regarding the memorial obelisk, the inscription for the plaque, if any, the handcrafted, one-of-a-kind obelisk memento, signed authorization for credit card charge payments if applicable and/or the additional form required to setup the pre-authorized checking option for prearrangements. This form also serves as a transmittal form.

B. Shipping

- All three forms, along with payment for all items need to be included with the cremated remains and shipped to:

Twin Rocks Undersea Memorial Policy and Procedure Statement

Placement

If for any reason Twin Rocks Undersea Memorial is unable to deploy a scheduled obelisk placement at a committed time, Twin Rocks Undersea Memorial will offer the family another scheduled time and Twin Rocks Undersea Memorial will be responsible for any additional costs associated with the new scheduled placement.

Obelisk Movement

Twin Rocks Undersea Memorial has carefully researched and personally designed our unique obelisk memorial shape to be the most reliable and stable memorial available today anywhere in the world. Twin Rocks Undersea Memorial will make every reasonable effort to place the obelisk memorials so that they will not be affected by storms or the impacts of boating activities. Under no circumstances will Twin Rocks Undersea Memorial be responsible for any damage or relocation of memorial obelisks caused by acts of man, nature, storms, or maritime accidents.

Multiple sets of remains

Twin Rocks Undersea Memorial will accept multiple sets of remains for interment into a single memorial obelisk under the following conditions:

- a. A maximum of 4 (four) sets of cremated remains can be interred into one memorial obelisk. All remains must be family, related by blood or marriage. Cremated pet remains may be interred with family remains, at the request of the family only. Each set of pet remains will be considered as 1 (one) family member.*
- b. Multiple interments must be performed at one time.
- c. An additional fee for handling multiple sets of remains may be charged.
- d. There may be limitations as to the names included on any plaques attached to memorial obelisks.
- e. Any special requests beyond the standard arrangement for the memorial obelisk may incur additional fees.

Scheduled Timeframes

Twin Rocks Undersea Memorial will make every effort to assure timely casting and placements of all memorial obelisks. It is understood that these obelisks are handcrafted and construction projects that can be delayed by weather and/or other factors.

***Pets**

Twin Rocks Undersea Memorial will allow for inclusion of cremated pet remains only with family requests. Each set of cremated pet remains shall be considered 1 (one) set of cremated remains in the maximum total of 4 (four) sets of cremated remains in one single memorial obelisk.

Broken Memorial Obelisks

Rarely memorial obelisks may break as they are removed from the mold or during transportation. In the unlikely event this should happen, Twin Rocks Undersea Memorial will, at its expense, recast the memorial obelisk or repair the obelisk, at its choice.

Payment

Payment in full is required before crafting and/or placement of any memorial obelisk.*

*Price for one handcrafted and placed obelisk, \$3,750.00. Memento pieces can be purchased for \$300.00 and will be personalized. Due to the nature of how our handcrafted monuments are created, the materials purchased and how the remains are permanently interred, the full purchase price is non-refundable.
